2. Registration:

Registration shall be performed by returning the enclosed forms to Beate Ruloff Event Consulting GmbH; it shall be binding in all cases. Registration implies acknowledgement of the Terms and Conditions for Participation in the Exhibition. Your registration will be confirmed in writing by Beate Ruloff Event Consulting GmbH. The exhibition agreement shall come about when confirmed in this manner.

The rights and obligations arising from this agreement shall not be assignable. Any inclusion of a further exhibitor in the rented stand area shall require the consent of Beate Ruloff Event Consulting GmbH.

3. Last date for registration; allocation of stands

The last date for registration is stated on the registration forms. Stands will be allocated according to the dates on which the registrations are received. Allocation of the stand positions shall be at the discretion of Beate Ruloff Event Consulting GmbH. After the registration has been confirmed and the stand allocated, Beate Ruloff Event Consulting GmbH shall be entitled to assign the exhibitor a different position for an important reason.

4. Assembly and dismantling times

The exhibitor undertakes to adhere to the assembly and dismantling times. At the end of the dismantling time the stands will be removed at the exhibitor's expense and stored with a forwarding company. Should the exhibitor fail to collect the stands from the forwarding company within a reasonable time after being requested to do so by Beate Ruloff Event Consulting GmbH, they shall be disposed of at the exhibitor's expense. The stands shall not be dismantled wholly or partially or otherwise cleared before the end of the exhibition. In cases of contravention the exhibitor undertakes to pay a contractual penalty amounting to half of the stand rental without incidental expenses.

5. Materials

The materials and decorations of the stands shall conform to Fire Class A 1/2 and/or B 1/2 as defined in DIN 4102, Part I. A description of the stand in this respect shall be submitted on request. The height of the stand shall not exceed 2.50 m. Any deviation from this height shall require the consent of Beate Ruloff Event Consulting GmbH. Electrical installations shall conform to VDE and TÜV requirements.

Beate Ruloff Event Consulting GmbH reserves the right to demand alterations to or removal of stand structures, decorations or fittings/equipment which do not conform to the regulations. Packaging materials/crates must be removed from the exhibition halls after assembly of the stands or stored in such a way that they do not impair the overall appearance of the exhibition. The exhibition management reserves the right to demand their removal. Should the exhibitor fail to meet such a demand, the exhibition management will have the objects removed at the exhibitor's expense.

Presence of personnel

The exhibitor shall ensure that personnel is present on the stand at all times during exhibition hours.

Insurance and liability

The exhibitor shall be liable for any damage in or around the exhibition building which is caused by him or persons acting on his behalf.

Beate Ruloff Event Consulting GmbH shall only be liable for damage caused through its own fault or that of persons employed in performance of its obligations in cases of gross negligence or intent.

8. Advertising outside the limits of the stand

The affixing of advertising posters or signs and the distribution of samples, brochures, leaflets etc. outside the limits of the stand is not the subject of this exhibition agreement and requires a separate arrangement.

9. Cancellation of the exhibition or change of date

Beate Ruloff Event Consulting GmbH reserves the right to cancel the exhibition or change the date for an important reason. Should the date be changed, exhibitors shall be entitled to give notice of their withdrawal from the exhibition agreement within three weeks of being informed of the new date. In this event the payment made by the exhibitor shall be refunded, minus 25% as a service charge. No claims of any kind shall exist beyond this.

10. Terms of payment

The agreed remuneration shall be due when the application is confirmed. Payment shall be made immediately upon receipt of the invoice. Should an exhibitor fail to pay at the proper time, Beate Ruloff Event Consulting GmbH reserves the right to cancel the agreement or claim damages for non-performance. Should the exhibitor fail to make the agreed payments at the proper time, Beate Ruloff Event Consulting GmbH shall be entitled to charge the sum of EUR 6.00 for each reminder. The letter putting the exhibitor in default shall be free of charge. In the event of delayed payment, interest of 2% above the Bundesbank discount rate shall be charged on the arrears.

11. Cancellation of the agreement

Should the exhibitor cancel the rental agreement and/or fail to take part in the exhibition, he shall be obliged to pay damages for nonperformance. The claim to damages by Beate Ruloff Event Consulting GmbH shall be 50% of the stand rental for a cancellation up to three months before the start of the exhibition and 100% of the stand rental for a cancellation after this date or for unannounced failure to appear. The exhibitor shall be entitled to prove that the damage did not occur or that it was considerably less.

12. Court of jurisdication

If the exhibitor is a registered trader, the agreed court of jurisdiction shall be Ratingen. If the exhibitor is not registered trader, the statutory arrangements shall be followed.
